



1880	Jacobus George Robbers founds NV Uitgeversmaatschappij Elsevier. The name is taken from the 16 th Century Elsevier family of Dutch booksellers and publishers

1919	Harcourt Brace & Company founded	Reed Business
1970	Mead Corp creates Mead Data Central	
1973	Mead Data Central begins offering the Lexis® service. Lexis is the first commercial, full-text legal information service.



Who is Univentio?

- 1952 Univentio founded, to provide patent document delivery
- 1996 W.G. Lagemaat purchased the business from his father Univentio begins aggregating patent data
- 2001 Univentio begins to offer patent data for license
- 2004 Univentio begins developing a patent search platform
- 2005 Acquired by LexisNexis

- Almost 100 authorities in Biblio
- 22 authorities in Full Text


- English MAT files for all non-English authorities
- Image files for all authorities
- Compressed .pdf files for all Full Text authorities *full text searchable*
- Data loaded faster than some authorities (e.g., USPTO)
- All full text and MAT files re-built every 3 years for continuous quality improvements – with advanced tagging
- Numerous data gaps filled (some examples)
 - EPO missing FT applications '78-'86
 - EPO missing FT grants '80-'86
 - CA and AT destroy documents
 - FR and GB non availability of Grants
- Other interesting projects under development


